The Taxi Advisory Committee (TAC) deliberates and recommends all policy and enforcement considerations for the entire taxicab industry to the city's Metropolitan Transit Systems (MTS) Board, which includes several City Council members.

Now two lease drivers who are UTWSD members and who received UTWSD endorsement will join the TAC in 2012 to put drivers' needs front and center on the table.

With only three weeks notice on the election date, UTWSD was able to mobilize a rapid outreach campaign and attract about one fourth of the estimated 1,500 lease drivers to the poll. A fair election was ensured by support and impartial observation provided by a range of organizations, including The San Diego Labor Council, Center on Policy Initiatives, Interfaith Committee on Worker Justice, Council on American-Islamic Relations, ACLU of San Diego, the Sheetmetal Workers Local 206, and the

## **UTWSD** Awards

All of the outstanding accomplishments and organizing of UTWSD in 2011 achieved recognition and support from two of San Diego's most progressive nonprofits working for change and equality in San Diego: The Center on Policy Initiatives and the Interfaith Committee for Workers Justice.

In October, UTWSD received the Center on Policy Initiatives (CPI) award honoring outstanding organizing of working people. CPI is a nonprofit research and advocacy center that works to end poverty by building a fair economy that allows working people to live with dignity. CPI's efforts in the community and their comprehensive research and analysis has helped to shape public debate for the last ten years, and CPI is regularly sought out by local and state policymakers on the economy, local governance,

and redevelopment. For the taxi drivers, CPI offered key staff and logistical support for the Taxi Advisory Committee (TAC) driver elections and has, at every step of the way, encouraged and contributed to UTWSD's efforts to shape local government policy on behalf of the drivers and their families.

At CPI's annual gala, the short film "Organize: The Power of a Collective Voice" featured UTWSD President Mikaiil Hussein along with award recipients, and UTWSD Strategist Dr. Jesse Mills presented the CPI award for Worker Organizing. Hussein also accepted a Certificate of Recognition from the California Legislature signed by State Assemblyman Ben Hueso.
