What an exciting year! The San Diego 2012 mayoral race mattered to taxi driver leaders and advocates because Carl DeMaio, one of the candidates, was one of only three San Diego City Council members who voted against taxi drivers having an equal voice on the city's Taxi Advisory Committee (TAC). We didn't want our hard "equal representation" work of 2011

undone, and immediately knew that we couldn't afford to have someone in office who didn't respect the hard working people

City Heights. What we liked most about Bob Filner was his continued commitment to helping marginalized people, from his days as a young Freedom Rider in the south, to empowering a largely immigrant work force by his promise to give everyone a seat at the table if elected!

Our UTWSD Voter Registration Team consisted of 9 drivers, all members of the East African community in City Heights. Along with three UTWSD staff, the team started working from the month of May until June 5th for the primary elections and continued the month of September until November 6th, the day of elections. Our outreach included phone banking and walking precincts with our friends at the San Diego Organizing Project

and the San Diego Labor Council. We registered community members all around San Diego, in East African restaurants, as well as house to house, and places of worships.

For our volunteer phone banking during day and night shifts, at the UTWSD office and at the San Diego Labor Council, we were able to engage the East African community members who only spoke Somali or Ethiopian dialects. And on the day of the elections the team was able to organize themselves to be at different areas in the city, calling the people

the thousands of dollars they receive from drivers so that they will available upon request for drivers to properly file their taxes.

Additionally, after our pressuring dozens of downtown hotels and MTS about illegal competition, Ordinance 11 now allows increased enforcement by MTS to write violations for charter vehicles, buses, and TCP's.

But we didn't stop there. We made health and safety a priority in 2012 by lobbying for cameras in all taxicabs, which we're hoping will go into effect in the new year. And we hosted two summer OHIP Interns who conducted a crucial driver health and safety survey.

At the Airport level, we also had many accomplishments. We stopped front of the line privileges after drivers bravely stood up, and ended additional \$0.38 surcharges.

2012 was also historic as we were welcomed as the first non-union workers to be affiliated with the San **Diego and Imperial County Labor** Council. A big "Thank You" to CEO Lorena Gonzalez!

And then there were the mayoral elections! UTWSD ended the election cycle in style! In total we knocked on over 5149 doors, registered more than 242 new voters, made hundreds of calls while phone banking, and gave rides to polling places. And most importantly WE WON!

Overall we achieved more than we sought out to do! I want to thank our team, our active members, Board of Directors, volunteers, friends, allies, brothers and sisters. Lastly, I want to give a personal thank you all the hard working San Diego taxi drivers, the Employee Rights Center and the San Diego Labor Council. Without all of you we could not have done this! Here's to an even more successful **2013!** And remember,

We are not alone. We have rights!

Health Survey Exposes Driver Concerns

This past summer we were fortunate to partner with the **Employee Rights Center and** the Association of Occupational and **Environmental Clinics through** their Occupational Health Internship Program (OHIP). OHIP is a summer program where college and graduate school students survey vulnerable populations of workers to document their health and safety issues on the job. Previous taxi surveys had been conducted in both New York and Los Angeles. This was the first study of its

kind conducted on taxi drivers this study possible including here in San Diego. OHIP interns Mina Nguyen and Roxana Said designed a wellrounded workplace health and safety survey and reached out to the most concentrated taxi stands in downtown, the Fashion Valley Mall, Mission Bay, Old Town, Pacific Beach, and the San Diego Airport Holding Lot.

50 drivers participated in the survey and more than 100 drivers received first aid kits as well as other helpful health and safety information from Mina and Roxana. We want to thank everyone who made

OHIP interns Mina and Roxana, the Employee Rights Center, the National Institute of Occupational Safety and Health, the Association of Occupational and Environmental Clinics, the California Wellness Foundation and all the drivers who participated! Let's continue working together to make a difference in the lives of taxi drivers!



KEY FINDINGS

- √74% of drivers have NO health insurance.
- ✓ A majority of drivers reported working 7 days a week for 12 hours per shift with no days off.
- ✓ 50% of drivers reported not taking any kind of break.
- ✓ The meal skipped most by drivers was Breakfast, followed by lunch.
- ✓ Many drivers avoid drinking water throughout the day so they only have to use the restroom on average 1 to 2 times per shift.
- ✓ 68% of drivers suffer from lower back pain due to their occupation.
- √70% of drivers report having been verbally assaulted while on the job.
- ✓ Most physical assaults occurred at night.
- √67% of drivers reported being assaulted by an intoxicated passenger.
- ✓81% of drivers would like cameras installed in their taxicabs, 67% would also like partitions.

Sarah Saez, Lead Organizer

Sarah has worked as an avid advocate and community organizer for the United Taxi Drivers of San Diego for the past two years. With more than eight years of organizing experience, Sarah applies her passion and skill to improve working conditions for taxi drivers through direct advocacy, empowerment, and increasing education and civic participation by drivers and their families.

A graduate from Barry University with a degree in Sociology and Criminology, Sarah is currently working on her Master's degree in nonprofit leadership at the University of San Diego School of Leadership and Education Sciences. Sarah has applied the humanistic and scientific perspectives of her graduate study to her UTWSD work, and has raised awareness that taxi drivers earn below poverty wages of \$4.23 per hour, has led a campaign against over-ticketing, and has promoted Ordinance 11 reform. Her focus on anti-retaliation protection, increased restroom mobility, increased taxi vehicle safety, and healthy drivers are at the core of UTWSD's work.

Her unrelenting determination and sincere belief in the

fundamental rights of the working poor, have propelled Sarah into a key leadership position for San Diego taxi drivers. Sarah has been a steadfast proponent for advancing the proposals that drivers merit equal representation on San Diego's Taxi Advisory Committee and has lobbied city council and board members to approve a recommendation to ensure democratic elections on San Diego's Taxi Advisory Committee.

Sarah has also created and maintained partnerships with an active network of local nonprofit supporters, including Realize Marketing which designs and maintains the UTWSD website. Sarah continues to reach out to the community on behalf of the United Taxi Workers to strengthen ties with important allies.

UTWSD could not have reached its major initiatives in the past year without Sarah's expertise and dedication and we have been fortunate to benefit from Sarah's knowledge, positive attitude, and zealous advocacy for workers' rights! As Mikaiil always says, "Sarah is everything for us."
